WHAT TO BRING:

ENGLISH CV LOGBOOK(S) ATPL(A) license or CPL(A) license + ATPL theory certificate MEDICAL license SUPPORTING DOCUMENTS for ME/IR rating JOC certificate (if no jet experience)

***FOR CAPTAINS:** how to calculate factored Hours.

Please use the following table to calculate your factorized hours by multiplying your total by the relevant indices listed.

Factored hours should only be hours in an aircraft, NOT simulator time. PIC time is Pilot in command time, NOT PIC u/s.

AIRLINE wide body jet	0.8	0.7
AIRLINE turbine (multi-crew)	0.8	0.7

MILITARY fast jet	0.7	-
Single engine/Rotary (single pilot)	0.3	-
Non-Airline flying	0.7	0.5
